### Introduction

Bradford Central PRU welcomes links to our website made in accordance with the terms of this policy. This policy is intended to assist you when linking to our website. By using our website, you agree to be bound by the provisions of this policy.

#### 1. Links to our website

Links directed to our website should not be misleading.

Appropriate link text should always be used in links directed to our website.

From time to time, we may update the URL structure of our website and, unless BCPRU agrees in writing otherwise, all links should point to [*URL(s)*].

You must not use BCPRU's logo to link to our website (or otherwise) without express written permission.

You must not link to BCPRU's website using any inline linking technique.

You must not frame the content of BCPRU's website or use any similar technology in relation to the content of the website.

#### 2. Links from our website

This website includes hyperlinks to other websites owned and operated by third parties; such hyperlinks are not endorsements or recommendations.

BCPRU has no control over the contents of third party websites, and BCPRU accepts no responsibility for them or for any loss or damage that may arise from your use of them.

We are not responsible for the privacy policies of third party websites.

#### 3. Removal of links

You agree that, should BCPRU request the deletion of a link to our website that is within your control, you will delete the link promptly.

If you would like BCPRU to remove a link to your website that is included on this website, please contact us using the contact details below.

Please note that unless you have a legal right to demand removal, such removal will be at our discretion.

#### 4. Cookies

BCPRU may send a cookie which may be stored by your browser on your computer's hard drive. BCPRU may use the information we obtain from the cookie in the administration of this website, to improve the website's usability and for marketing purposes. BCPRU may also use that information to recognise your computer when you visit BCPRU's website, and to personalise BCPRU's website for you.

#### 6. Names, pictures, and content

BCPRU follows a policy of seeking parents' permission before using images which show pupils on the website.

No other private information about pupils is ever published on the website such as surnames or contact details. Children will only be shown in photos where they are suitably dressed.

Personal details of children or staff, such as home addresses, telephone numbers, personal e-mail addresses, etc., will not be released via the website.

Links to external websites will be checked thoroughly before inclusion on the school website. The sites will be checked for the suitability of their content for their intended audience.

Any text written by pupils will be reviewed before inclusion to ensure that no personal details are accidentally included that could lead to the identification of the pupil, e.g. membership to after school clubs.

All written work will be reviewed to ensure that it is in no way defamatory.

Written work will be checked to ensure (as far as possible) that no copyright or intellectual property rights are infringed.

All written material will be checked for its suitability for its intended audience.
